Josh has spoken to the State regarding the issue of exhibitors raising their own animals and are waiting for a Certification from CDFA if they ate going to exempt them and the form has to come from the State. After a lengthy discussion, Kenny Saphein moved that each exhibitor will need to obtain a Certificate from the Breeder for the Market Swine and upload a copy at the time of entries. (Individual 4-H/FFA Exhibitors raising their own swine project is waiting for further information from CDFA and <u>is NOT PART OF THIS MOTION</u>. It was seconded by Jimmy. Motion passed unanimously. **Facilities/Credentials:** Kevin reported he is getting bids from Republic Garbage.
